

**TOWN COUNCIL**  
**Minutes of Meeting**  
**October 6, 2009**

1. The regular monthly meeting of the Port Hawkesbury Town Council was held in the Shannon Studio, Port Hawkesbury Civic Center, on Tuesday, October 6, 2009, at 7 p.m.
2. Present were Mayor W.J. MacLean; D/M M. MacIver; Councillors J.King, H. MacDougall and K. Anderson; CAO, Jim Davis; and Town Solicitor, L.K. Evans.
3. Mayor MacLean called the meeting to order and following items of business were attended to:

4. Mayor MacLean welcomed Raylene Bowman, NSCC Strait to Work Program
5. Ms. Bowman thanked Council for their continued support over the past couple of years and briefly went over the program. Mayor MacLean thanked Ms. Bowman for her presentation.

**OTHER BUSINESS**

16. *i) Award of Airport Tender(Asphalt Patching & Crack Sealing Runway*

17. One tender was received, that being from Roadsavers in the amount of \$90,950. (This tender is recommended by Steve MacDonald, P.Eng., Project Consultant)

18. *It was moved by Councillor King, and seconded by Councillor MacDougall that the tender for Asphalt Patching and Crack Sealing for the Airport be awarded to Roadsavers in the tendered amount of \$90,950.00. On the question, Councillor Anderson asked if the monies are available; in response the CAO reported there is no cost to the Town. Motion carried.*

19. *ii) Award of Street Paving - Building Canada Project*

20. *It was moved by Councillor King, and seconded by Councillor MacIver that the "Asphalt Paving Tender" be awarded to Ocean Paving in the amount of \$589,486.00; with the deletion of Spruce & Napean streets and that any excess funding requirements be funded from the Capital Reserve Account. Motion carried.*

**GRANVILLE STREET PROJECT**

21. *It was moved by Councillor King, and seconded by Councillor MacIver that the Granville Streetscape Project be included in the Capital Budget process for 2010/2011 and that the Town's share of 25% of funding (\$77,280) may be provided for from the Town of Port Hawkesbury Capital Reserve Account. On the question, asked it we would vote on it at a later date. Councillor King stated that we have to make a commitment first, and then we will vote on it later. Motion carried.*

**HALLOWE'EN**

22. *It was moved by Councillor MacDougall, and seconded by Councillor King that the 'Trick or Treat' activities for Hallowe'en will end at 8 p.m., with no masks permitted after that time. In addition, a curfew of 10 o'clock has been set that requires youth 16 years and under to be off the streets; and that the Director of Parks & Rec., Jim Pyke, be asked to have the tennis and ballfields lit; also that he work with SAERC Youth, the Fire Dept. and the RCMP for Hallowe'en coverage. On the question, Councillor Anderson suggested that maybe our Solicitor could look into making a By-Law for Hallowe'en when the review of the By-Laws is done.*
