

## **BOUNDARIES**

1. The Boundaries of the Town of Port Hawkesbury are, and shall be as follows:

**BEGINNING** *at the middle of the bridge at the head of Ship Harbor in the Strait of Canso, said bridge being on the old road (abandoned in 1970) between Port Hawkesbury and Point Tupper and which also forms a point on the boundary line between Inverness County and Richmond County;*

**THENCE** *in a Southerly direction along the center of the channel a distance of one fifth (1/5) of a mile more or less, to a point, said point being the most southerly corner of the Town of Port Hawkesbury's boundary line, also being the turning point for the boundary line between Inverness and Richmond Counties, said line being part of the Western boundary line of the Town of Port Hawkesbury;*

**THENCE** *in a northeasterly direction running to and along the Nova Scotia Power Corporation's transmission Right-of-way, line, a distance of six thousand three hundred and seventy (6,370 ft) feet, more or less, to a point in the center of a brass plug set in a six (6") inch concrete monument, said point being on the boundary line which divides Inverness and Richmond Counties; said line being the southern boundary line of the Town of Port Hawkesbury;*

**THENCE** *in a Northwesterly direction, along the Nova Scotia Power Corporation's transmission Right-of-way line, a distance of twelve thousand--seven hundred and thirty (12,730 ft)feet, more or less, to a point at the South corner of land now or formerly belonging to Louis Davis, said line being the eastern boundary line of the Town of Port Hawkesbury;*

**THENCE** *in a southwesterly direction along the Southern line of lands now or formerly belonging to Louis Davis, a distance of Six Thousand, four hundred (6,400 ft) feet, more or less, to a point on the high water mark of the Strait of Canso, said line being the northern boundary line of the Town of Port Hawkesbury;*

**THENCE** *in a southeasterly direction along the various windings of the high water mark, of the Strait of Canso, a distance of twelve thousand one hundred (12,100 ft) feet, more or less, to the place of beginning said line being the Western boundary line of the Town of Port Hawkesbury And east 1,034,717.086;*

**THENCE** *along the high water mark of the Strait of Canso in a southeasterly direction a distance of twenty-seven hundred and ninety (2,790') feet more or less to the place of beginning.*

### **INTERPRETATION**

1. *In these By-Laws, unless the context otherwise requires, the following expressions shall be construed in the manner in this section mentioned:*

- "Chair"** *used in respect to the Town Council, means the Mayor Presiding Councillor or Chairman presiding at any meeting of the Town or a Committee thereof.*
- "Clerk"** *used in respect to the Town Clerk, means the Town Clerk of the Town.*
- "Company"** *Includes Corporation.*
- "Councillor  
or  
Member"** *means a member of the Town Council of the Town.*
- "Minister"** *Minister means the Minister of Municipal Affairs.*
- "Owner"** *when used in relation to any property within the Town. Includes an agent having the care or control of any property of an absent owner.*
- "Police Court"** *means the Court of the Stipendiary Magistrate for the*

- "Stipendiary Magistrate"** *Town. means the Stipendiary Magistrate of the Town and includes the Deputy Stipendiary Magistrate of the Town and also any additional Stipendiary Magistrate appointed under the provisions of any enactment.*
- "Streets"** *includes every street, highway, lane, road, footway, thoroughfare, alley, by-way, passage, court, square, sidewalk or bridge and every part thereof, lawfully used by the Public of the Town.*
- "Town"** *means the Town of Port Hawkesbury.*
- "Town Hall"** *means the building in which the Town Clerk has his office.*
- "Town Solicitor"** *means the Town Solicitor of the Town whether appointed annually or in a particular matter of matters and includes the Deputy Town Solicitor.*

- 2. The provisions of "The Interpretation Act" Chapter 151 of Revised Statutes of Nova Scotia, 1967, and amendments thereto, in so far as applicable, shall apply to all By-Laws of the Town of Port Hawkesbury and the interpretation of the words, expressions, and clauses therein stated shall be given to the same respectively where used in the said By-Laws, except in so far as the same are inconsistent with the context or with the intent and object of the By-Laws.*
